
Biblical principles for giving

- Christian giving is *supernatural* (2 Cor 8:7). We should ask God to spur us to give as He wants us to.
- Christian giving is *spontaneous* (2 Cor 9:7). We should give because we want to, not because we are told to.
- Christian giving is *sacrificial* (2 Cor 8:3). Our giving should contain an element of sacrifice.
- Christian giving is *systematic*: (1 Cor 16:2). We should plan how we give and avoid the "let's see what I have in my pocket today" syndrome.
- Giving is *symbolic*: (2 Cor 8:5). Our giving should be a token of a life given wholly to Christ in response to his life given for us.

The Church's Income


Our unrestricted income for the year to 31 December 2021 is forecast to be £363,000.

90% of this comes from gifts from church members and the gift aid we can claim on top.



The Church's Expenditure

Our unrestricted expenditure for the year to 31 December 2021 is expected to be £360,000



The parish share predominantly funds salaries and training for the church's clergy meaning that more than three quarters of our expenditure is effectively on staffing costs.

How can I give?

The most helpful way to give is by standing order. This helps us to predict our future income levels, which in turn allows us to plan our expenditure appropriately. You can either use the form overleaf or set up directly with your bank using the details on the form.

If you wish to make a one-off donation to the work of St Bart's, this can be done by making a bank transfer using the bank details on the standing order form. Alternatively, gifts can be made by placing cash or a cheque (payable to St Bartholomew's PCC) in the collection plate at King Edward Road.

Please email the treasurer with details of any giving set up directly with your bank.

Gift Aid

If you are a UK taxpayer, we can claim an extra 25p from HMRC for every £1 you give, whether regular or one off. To allow us to do this, please complete the Gift Aid declaration on the reverse.

Higher rate taxpayers can claim additional tax relief (approximately another 25p). Please contact the treasurer if you would like to understand this further.

Giving beyond St Bart's

In addition to supporting ministry through St Bart's, we encourage individuals and families to consider the challenge of supporting Christians in need around the world. There are some excellent parachurch organisations that work in these areas. Please speak to us if you need any suggestions.
